Notification

In continuation of Government Notification No. 2768/I(2)/2010-04(8)-91/2010, dated 08 December, 2010, issued under sub-section (1) of section 4 read with sub-section (4) of section 17 of the Land Acquisition Act, 1894 (Act. No. 1 of 1894), the Governor is pleased to declare under sub-section (1) of section 6 of the said Act that he is satisfied that the land mentioned in the Schedule below, is needed for public purpose, namely for the construction of Devsari Hydro Electric Project through Satluj Jal Vidyut Nigam Ltd. in Village Icholi Lagga Sailkhola, Tehsil-Tharali, District Chamoli. Therefore, direct the Collector of Chamoli under section 7 of the said Act to take action for the acquisition of the said land.

2- The Governor, being satisfied that the case is one of urgency, is further pleased under sub-section (1) of section 17 of the said Act, to direct that though no award under section 11 has been made, the Collector, Chamoli may, on the expiration of 15 days from the date of the publication of a notice under sub-section (1) of section 9, take possession of the land, mentioned in the Schedule below for the said public purpose.
